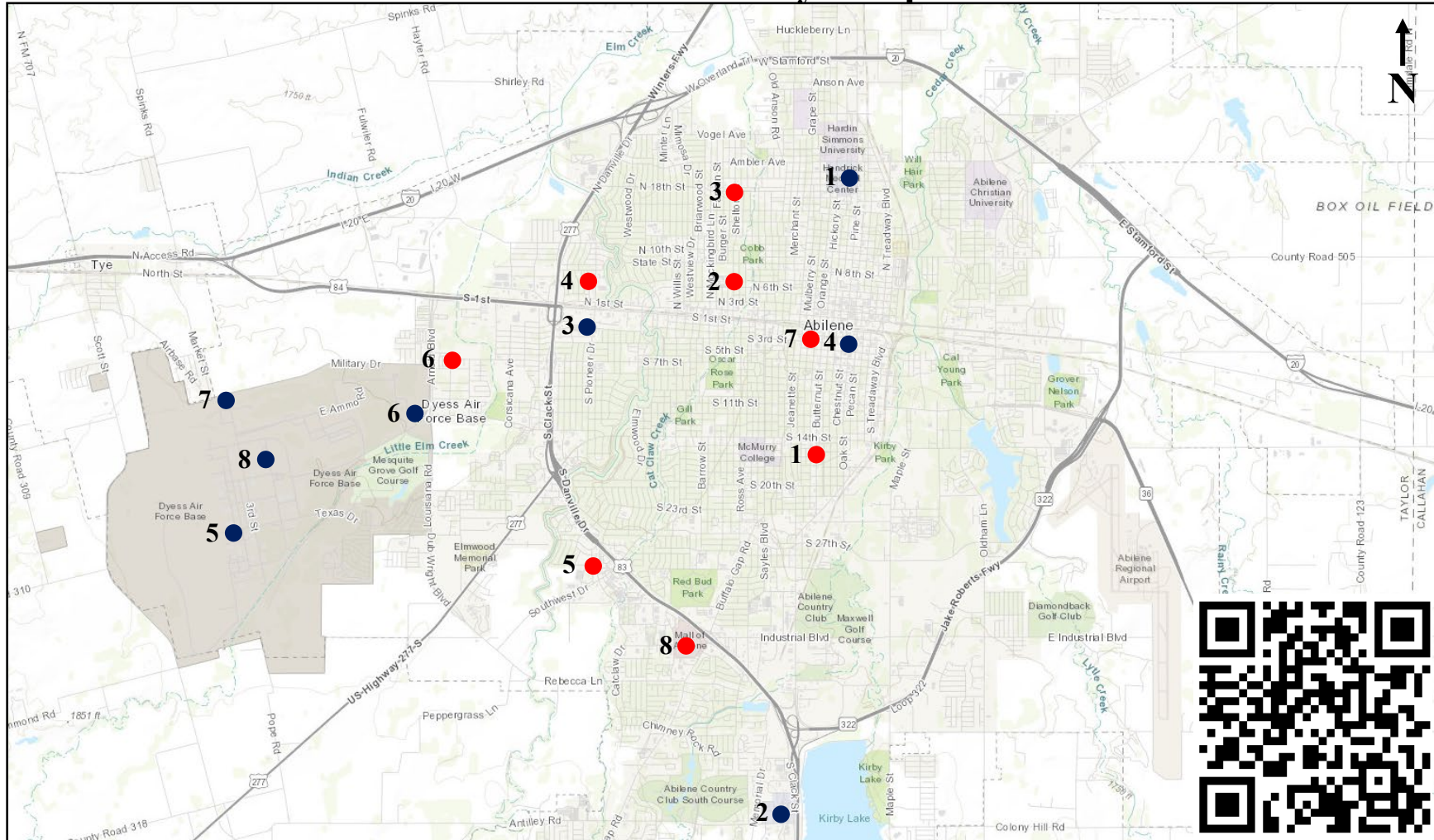

Arnold Gate

- 24-hour operations

Visitor Control Center (VCC)

- 0700 – 1600, M – F
- VCC is closed for holidays & family days
- Services provided:
 1. Base Passes & DBIDS Cards
 2. Entry Authorization Lists (EALs)
 3. Veteran Health ID Card (VHIC) Access

Tye Gate

- 0600 – 1700, M – F
- Gate is closed for holidays & family days

Tye Search

- 0600 – 1400, M – F
- Gate is closed for holidays & family days
- Afterhours access is through Arnold Gate

Delaware School Gate

- 0715 – 0815 & 1445 – 1600, M – F
- Gate is closed when school is closed

After Hour Passes

- Trusted Traveler is Authorized at Dyess AFB:
 1. Only Valid for AD military & their spouses
 2. Allows base access for everyone in the vehicle without the need for a Visitor's Pass
 3. Everyone over 16 years old must have a valid ID
- Visitor Passes can be acquired at Arnold Gate:
 1. Please ask the gate guard for assistance
 2. You will be asked to go to the VCC Parking Lot

Dyess AFB's Weapons Policy

The following matrix provides a quick reference outlining Dyess AFB's policy regarding authorized transportation, storage, and carry of Personally Owned Firearms (POFs) on the installation.

Personnel authorized to transport, store, or carry POFs on Dyess AFB must do so in accordance with all applicable local, state, and federal laws and policy to include the Dyess Base Defense Plan (BDP); 18 USC 922; 18 USC 930; DAFI 31-101, *Base Defense*; AFI 31-117, *Arming and Use of Force by Air Force Personnel*; and Texas Statutes.

	Authorized to transport POFs inside a vehicle Unloaded and properly secured prior to entering the installation. Reference BDP for full guidelines.	Authorized to store POFs in approved storage locations Reference BDP for approved locations.	Authorized to carry a POF on the installation Reference BDP for additional details.
